

Regulations for consultation and reproduction of the papers in the Paul Kahle Archive (1875-1964) of the 'Biblioteca di Orientalistica' (Library of Oriental Studies)

1. The Biblioteca di Orientalistica (Library of Oriental Studies) preserves the library holdings of Paul Ernst Kahle and the papers he produced in the course of his scientific activity. The catalogue of the Archive is available at: http://www.paulkahle.unito.it/index.php/About/base_search
2. The user, after completing the 'Application for consultation...' form (available at: <https://www.bibliosum.unito.it/it/biblioteche-e-mediateca/biblioteca-di-orientalistica/fondi-librari>) and accepting the provisions of the Law on Copyright n. 633 of 1941 and subsequent amendments, art. 93-95 and by the deontological rules for treatment for archiving purposes in the public interest or for historical research purposes published pursuant to art. 20, paragraph 4, of Legislative Decree 10 August 2018, n. 101 - 19 December 2018, for study and research reasons may submit a request for consultation of documents on site or remotely.
3. Documents containing sensitive data revealing state of health, sex life or confidential family relationships are consultable after seventy years from the date of issue, pursuant to Article 122 paragraph b) of the 'Code of Cultural Heritage and Landscape, pursuant to Article 10 of Law No. 137 of 6 July 2002' (Legislative Decree No. 42 of 22 January 2004).
4. For in-house consultation, users must make an appointment by sending a request to biblio.do@unito.it, fill in the appropriate form and show a valid ID at the entrance. It is possible to request the consultation of 3 archival units at a time.
5. For remote consultation, it is necessary to fill in the appropriate form to be sent to biblio.do@unito.it attaching a copy of a valid ID document. Remote consultation will be possible only if the conservation status of the documents is such as to allow them to be scanned. Remote consultation will take place via read-only document sharing for a period of 3 months. It is possible to request 3 archive units at a time. The processing time for requests will be determined in consideration of office availability.
6. Photo reproduction for study and research purposes is permitted, with prior authorization and under the supervision of the library staff, only on the premises with their own means, without contact with the original documents and without the use of flash or lamps.
7. In the event of publication or dissemination of data from the Archive, the user undertakes to always take all necessary precautions so as not to infringe the rights, freedoms and dignity of the persons concerned (e.g. by blacking out names or using only dotted initials).
8. For facsimile publication of documents or parts thereof, the following is required: "Paul Kahle Fund [marking of the relevant archival unit]. By concession of the "Biblioteca di Orientalistica – Dipartimento di Studi Umanistici, University of Turin".
9. In the event of a publication concerning the Archive, the user is required to deliver a copy to the library.
